OLD BUSINESS:

Ordinance #01-12-09-08

Motion was made by Hawn, seconded by Brown to pass on final reading **Ordinance** #**01-12-09-08**, an ordinance to amend the zoning ordinance of the Town of Englewood, Tennessee with updates and corrections. Hawn Aye, Brown Aye, Moses Aye, Brock Aye and Roach Aye.

December 2008 Minutes

2007-2008 Audit Report

Richard Hill with Mitchell, Emert & Hill addressed the Board with the 2007-2008 audit report. Hill stated that the audit reflected no findings and that the town had did well overall.

General Ledger

City Recorder Sondra Denton addressed the Board concerning the general ledger. Denton stated that in November 2004 a representative from Local Government

could not recall the Town 's general ledger ever balancing. Since January 2005, up to now, the general ledger has balanced consecutively. Denton stated that she wanted to make the Board and the citizens of Englewood aware of the accomplishments that have occurred with the conscientious help of all the staff of the Town. Town Manager Robert Cass then stated that the employees of the Town, in every department, were all hard workers and the Town was lucky to have each one of them. He stated that the only way to accomplish what the Town had over the last four years was by having employees that enjoyed their jobs and cared about their responsibilities.

Laser Printer

Motion was made by Hawn, seconded by Brown to purchase a laser printer in the amount of \$1,856.25. The printer will take the place of the OKI Data printer that currently prints the utility bills.
