# **Mayor Communications:**

Mayor Roach stated that the contractors will be here Thursday November 12, 2009 to bid for the I & I project. He further stated that Richard Hill will be here the week of November 16, 2009 to work on the 2008-2009 fiscal year audit.

## **Old BUSINESS:**

## PAX MIXING SYSTEMS

**Motion** was made by Brock, seconded by Moses to accept Pax Mixing Systems' quote to install a mixer at the water tank on Highway 411. Hawn Aye, Brown Aye, Moses Aye, Brock Aye and Roach Aye. (The Schedule of work and fees are attached to the minutes in the minute book.)

#### ORDINANCE #11-09-09-14

**Motion** was made by Brock, seconded by Moses to pass on Final Reading **Ordinance** #11-09-09-47; an ordinance to amend section 18-106 of the Municipal Code of the Town of Englewood, Tennessee to provide for a water meter tap fee increase stating that all meter tap fee's larger than ¾ inch will be cost plus 10% to install the meters. # APPRAISALS FROM TML

Town Manager Cass addressed the Board concerning TML Insurance cost appraisals for certain buildings in town. Cass asked the Board to make suggestions regarding what they thought that the buildings would be worth. Mayor Roach stated that he would think the buildings could be insured for half of what the appraisals were. **Motion** was then made by Hawn, seconded by Brown to have Cass make a list of the buildings -along with a fair value to be insured- and present it to the Board at next month's meeting.

# LETTER TO PROPERTY OWNERS – CONDEMNDED HOUSES/OVERGROWN LOTS

Cass then addressed the Board concerning non compliant property owners who have been sent letters regarding houses which needed to be renovated or demolished and overgrown/dirty lots. Cass stated that further action needed to be taken since he was not getting a response from the violators. The Board then agreed to have the town's attorney send out letters in regard to the violators.

#### **DUSTIN TINSMAN**

**Motion** was made by Hawn, seconded by Moses to notify Dustin Tinsman that he is in violation of the Town's R-1 Zoning Ordinance. Mr. Covington has stored dumpsters within a residential zone and will have one hundred and eighty days (180) to have them

## ONE METER FURNISHING UTILITIES FOR TWO BUILDINGS

The building is located on Main Street and is owned by Darrell McConkey. The Board further agreed that each business would pay separate monthly bills. #### WILSON APARTMENTS MINIMUM BILL CHARGE

David Truelove had requested letters be presented to the Board on his behalf requesting that he be invoiced for the master meter at Wilson Apartments instead of paying a monthly bill. Truelove stated that he was willing to pay for any water which the meter shows, but he did not think it was fair to pay a minimum bill for no overage since the apartment tenants each pay their bills. **Motion** was then made by Hawn, seconded by Brown to allow Truelove to be invoiced when the meter shows an overage. Hawn Aye, Brown Aye, Moses Aye and Brock Aye. Raymond passed.

## **DELINQUENT PROPERTY TAX SALE**

City Attorney Doris Matthews addressed the Board concerning the 1998-2005 delinquent property taxes. Matthews stated that there will be a tax sale in December 2009 for the property(s) which the owners have not paid the past due taxes.
